HCHSAA is a charitable organization committed to advance the mission of Hunter College High School as a school for the intellectually gifted, and to serve, connect, engage, and educate the school's alumnae/i community. Providing foresight, oversight and insight, Board members are the engine that powers the organization's mission and cause. To be an effective member of the board, your passion for HCHSAA's mission, enthusiasm, time, talent and treasure, and excitement for helping in a variety of ways, combined with concrete preparation and action are needed. To that end, the requirements and expectations to serve on the HCHSAA Board of Directors are as follows:

- Nominees shall have demonstrated financial support and/or time to the AA during the last three years.
- Board members shall participate in board activities, including attending at least three of four Board meetings annually, with mandatory attendance at the July board meeting. Board meetings are held quarterly, generally on the second Tuesday of July, October, January & April from 6:30-8:30 p.m. eastern time. The FY 2025 meetings will be held on 7/9/24, 10/8/24, 1/14/25, 4/8/25. Meetings are hybrid inperson and via video conference.
- Board members shall support the HCHSAA financially by participating in the HCHSAA give and get policy as follows: Board members are required to make a minimum annual gift of \$500 (if this is a financial hardship, please apply regardless as alternate ways of donating can be discussed); Board members are required to secure 3 donations and/or match gifts of at least \$500 from fellow alums; and Board members are required to make introductions to the Executive Director of 5 prospects/donors with the capacity to make a gift of at least \$500.
- Board members shall support HCHSAA through participation in events held for donors, members, and alumnae/i by attending a minimum of three events annually, such as Evening of Thanks, Annual Meeting/ Reunion, Board retreat, or any event held in your residential region.

Board term is three years. Directors may serve up to two consecutive terms and then serve again after a one-year hiatus, but priority will be given to well-qualified candidates who have not previously served on the Board.
