## Meet the HCHSAA Board Candidates 2024

The Nominating Committee is pleased to present this slate of endorsed candidates for membership positions on the HCHSAA Board (class C, terms ending 2027):

Dave currently serves as the CEO of Apprentice, a marketplace which connects college students with entrepreneurs, which he co-founded with another Hunter alum. He is also the Chairman of the Board of The Nursing Beat, a privately held company. He also serves on the Board of Grateful Giving, a nonprofit. Previously Dave served on the Port Washington School Board and the Board of another local nonprofit, The Education Foundation.
