OUR HISTORY

The HCHSAA was established by a group of alumnae in the early 1970s during the New York City and State fiscal crises to provide support to Hunter College High School, when it was at risk of being closed. In 1997, HCHSAA was incorporated under the Not-for-Profit Corporation Law of the State of New York and, in 1998, it was determined by the Internal Revenue Service to be exempt from taxation as an organization described in Section 501(c)(3) of the Internal Revenue Code.

Event Planning: The HCHSAA coordinates regular programming including the Annual Reunion, guest panels, and group/chapter meetups across major cities.

WHAT WE DO

Outreach and Connection: The HCHSAA maintains connectivity between alumnae/i, current students and faculty.

Fundraising and Grants: The HCHSAA provides financial support to the high school and its students for both immediate needs and long-term projects. Funding has gone towards the Visiting Artists Series, Diversity & Inclusion initiatives, and the Debate and Robotics teams among other needs.

GRANTS 2023 - 2024

- For the 3rd year the AA funded transportation for admitted 7th graders from underrepresented communities who live far from HCHS, and whose families faced significant logistical and economic barriers to sending their child to Hunter. This program has had a material impact and we are in discussions with HCHS to expand it.
- The AA sponsored the school's digital marketing and outreach campaigns to increase awareness of Hunter in underrepresented areas, resulting in a 500% uptick in interest from prospective students living in these communities.
- Funded to host Sam Ahn '20 and the Yale Whiffenpoofs at HCHS
- Washington Seminar Program sponsorship
- AA Sponsored the 11th Grade HCHS Cultural Education Field Trip requested by the Social Studies department to the 9/11 Museum.
- Grant to the class of 2024 to underwrite prom costs
- Grant to middle school soccer coaches to lead the Hunter Boys Soccer team on a trip to London for a series of games against independent day schools
- HCHS has asked the AA to help to launch a few initiatives designed to strengthen the cultural, educational and mental health of the students and faculty.
 - College Tour A commitment to underwrite the cost of busses, hotels, meals and chaperones for feewavier eligible juniors. The three-day college visitation tours private, public, large and small NYS institutions of higher education.
 - Support for the Mental Health and Suicide Prevention Programming HCHS is interested in entering into
 a 3-year partnership with <u>JED Foundation</u>. This partnership is crucial given the current climate of
 increased need for students' social, mental and emotional health.
 - Student Faculty & Diversity Conferences HCHS seeks the resources to support student and faculty participation in diversity, inclusion and belonging conferences.
